Community support raising hope

When your best friend, family member or favorite coworker tells you that they have cancer, it creates an awful feeling of helplessness. You want to help. But the best ways to help are not always clear. My hope is that one of the first things you tell them is to call Cancer Services of Northeast Indiana.

Cancer Services provides innovative programs, effective solutions, and unending compassion to families in our community that are impacted by cancer. Sometimes it seems like magic. It's not. It happens because of a lot of hard work and dedication from hundreds of volunteers, a small staff, and many donors.

Providing financial assistance, equipment, supplies, nutrition consultations, mental health counseling and support groups, etc. to more than 4,000 families every year requires a lot of financial support from the community. It will require more than \$1.8 million in 2022.

A significant portion of the resources needed comes from businesses, school groups, civic organizations and individuals who hold fundraisers benefiting Cancer Services. In 2020, people organized and held community-based events that raised nearly \$60,000.

These events are always a fun and innovative way to show support for people with cancer. They include golf outings, concerts, auctions, motorcycle rides, bake sales and lemonade stands.

Unfortunately, many of the groups that hold annual fundraisers for Cancer Services have not been able to because of COVID-19. I'm hopeful that as COVID numbers decline in our community, groups will once again be able to hold these events supporting people with cancer.

All these fundraisers, no matter the amount raised, not only provide both practical and emotional resources to local people affected by cancer, but these events also build awareness of the assistance that is available at Cancer Services. These events act as proof of the community's support for people with cancer. They demonstrate that no one goes through cancer alone.

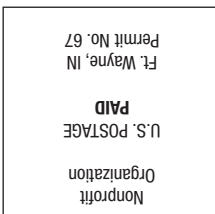
