A New Massage Program to Complement Treatment and Wellness

Cancer Services is very pleased to announce that on June 8, 9 and 10, nationally-recognized trainer Tracy Walton, MS, LMT, will present *Caring for Clients with Cancer: Simple Steps to Safe, Effective Massage Therapy* at the Cancer Services facility.

This very special training opportunity is open to certified massage therapists who have completed a recognized professional training program in massage therapy. Participants will receive 24 hours of National Certification Board for Therapeutic Massage and Bodywork (NCBTMB)-approved instruction, handouts, training manual and certificate of completion. A portion of the training will include hands-on instruction with cancer patients.

Massage therapist, researcher, writer and teacher Tracy Walton focuses on massage therapy for people with cancer, offering instruction and writing in oncology massage. She works and trains others to bring safe, effective massage therapy to people in cancer treatment, at end of life, and in survivorship.

Tracy's writing appears often in *Massage Therapy Journal*. She also writes a regular column on oncology massage in *Massage Today*. Currently she's working on a textbook, for Lippincott Williams & Wilkins on medical conditions in massage therapy. Best known for the intensive continuing education course for massage therapists, *Caring for Clients with Cancer*, Tracy has taught nationally since 1999.

In 2003, Tracy was selected by the American Massage Therapy Association as teacher of the year. Before that, she taught physiology and pathology at the Muscular Therapy Institute (MTI) in Watertown, Massachusetts, for 13 years. She chaired the MTI science department for eight of those years, and served as Academic Dean. As a researcher, Tracy has worked on several research projects on massage therapy and cancer, including a National Cancer Institute (NCI)-funded study of massage for people with metastatic cancer done at the Beth Israel-Deaconess Medical Center in Boston.

In addition to the expertise this training brings to therapists in our community, people with cancer will benefit
