## Getting Inspired

“If you could take a time out from the day to day responsibilities, what would you do to find renewed inspiration for your mission?” That was essentially the question Foellinger Foundation posed to non-profit leaders last year as part of their Inspire Grant application and in celebration of the foundation’s 50th anniversary.

The staff and executive committee at Cancer Services gave the question considerable thought and chose to explore what complementary care can mean for a person in cancer treatment and post-cancer treatment.

Complementary therapies are used to reduce pain, stress and anxiety, not to cure disease. They can enhance a patient’s well-being and quality of life. Typically, they are non-invasive, inexpensive and pleasant. Most importantly, they are activities that can be managed by the individual. For people with cancer, having control during a time when loss of control seems all around is a very positive experience.

Many complementary therapies fall within one of three categories: touch therapies, movement therapies and expressive therapies. Professional massage, reiki, reflexology, craniosacral therapy, healing touch, acupressure and acupuncture fall in the touch category. They generally involve a trained practitioner placing his or her hands on the recipient in a specialized manner. With the exception of acupuncture, the therapies do not generally use tools or devices and most can be done while the recipient is fully or partially clothed.

In the case of movement therapy, many of these tech-

## Being well and feeling better

*Charlie Greer was diagnosed with head and neck cancer in 1999. His surgery involved a wide incision across his throat. He had very limited physical therapy afterward and was left with a great deal of scar tissue and limited range of motion. He had his first massage in 2004 at Cancer Services and continues to this day.*

*Charlie wants people to set aside their fears and misconceptions about massage and give it a try. “Your massage therapist is a person who can help you. He or she is a trained professional who knows what you need and keeps getting more training on the latest information. They are professionals who can help you with cancer issues after your treatment.” He also explains that his therapist gives him exercises that he can do at home between appointments. Charlie says because of his monthly sessions, he sleeps better and feels more relaxed “head to toe.”*

niques resemble exercise. Disciplines such as yoga, tai chi, and qigong can be beneficial for people with cancer. These gentle exercises can increase the flow of natural endorphins, improve breathing, maintain muscle tone and facilitate better sleep and lessen mood swings.

Art and music therapy as well as journaling and laughter therapy are examples of expressive therapies. Sometimes people struggle to express their feelings about their cancer. They may hesitate to share the fear they feel with people close to them. They may think their anger is inappropriate. They often want to protect family members from what they perceive are negative emotions. By expressing these emotions through art-making, therapeutic drumming and writing, individuals can often gain control of their feelings and more proactively manage their lives. A room full of cancer patients who are laughing may seem incongruous but joy and laughter are primal emotions for human beings. As anyone who has ever experienced the infectious nature of a chuckling baby knows, laughter is contagious and can make you forget your anxieties or lessen their intensity. Laughter therapy is a growing field of interest today.

Because of the support of Foellinger Foundation, staff and board members are busy taking the opportunity to be inspired. They are experiencing a wide variety of complementary therapies including: massage, qigong, reflexology, guided imagery, therapeutic drumming, nutrition counseling, acupuncture, raindrop therapy, personal exercise training, hypnosis, reiki and more.

Learning new things is exciting! Sometimes we have to be startled out of our routines in order to be open to new experiences. The life-changing nature of a cancer diagnosis does that for some people.

Cancer Services' mission is to provide practical resources and emotional support for people with cancer and their families. 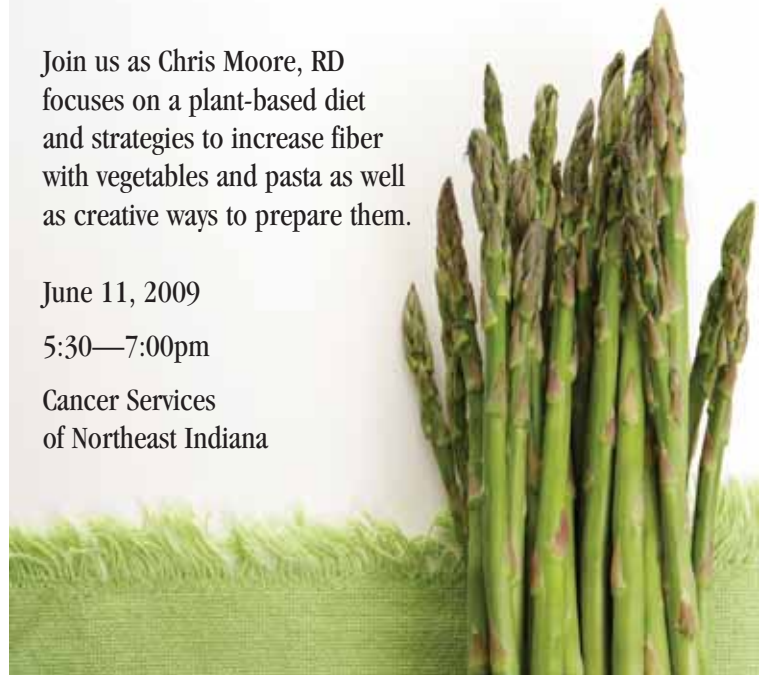
