Lasting gift to the community she loved

"She felt the community was good to her and her family and she wanted to give back," said Ron Felger. "She just loved Fort Wayne and wanted to help."

Ron was a longtime friend as well as the attorney for Dianne Koch, a local businesswoman who devoted her life to making a brighter future for others and helping her community.

Earlier this year, he had the honor of delivering her final gift to her beloved community when he visited several local non-profits, including Cancer Services of Northeast Indiana, and presented substantial donations from Dianne's estate.

Her wish was to help her community.

Dianne, who died in 2016, left a bequest to Cancer Services in her will. Her gift will help thousands of people who are impacted by cancer access needed resources for many years to come.

Ron remembered meeting with Dianne about her final gift to the community she loved so much. "She wanted to get it all down in black and white. She wanted to make sure her wishes were fulfilled. Her wish was to help her community."

For nearly 20 years Dianne taught English and Television Production at Snider High School. She changed the lives of all her students with more than one going into the broadcasting profession because of her. She was the "favorite teacher" of countless students.

Then she made it her business to keep people safe in their homes. She worked side-by-side with her beloved husband, Steven, at Certified Burglar & Fire Alarm Systems, until she lost him to lung cancer in 2012.

"Cancer Services provided help when it was needed and that stuck with her," Ron said. "She wanted to make sure the resources would be there for others."

Dianne's planning and generosity mean that her contributions to the community she loved so much will continue long into the future.
