COVID-19 even harder for people with cancer

Cancer medications weaken the immune system, treatments are being delayed, and in the worst cases, cancer patients are losing their jobs and health insurance benefits.

A survey by the American Cancer Society found nearly half of cancer patients reported the pandemic is harming their mental health; 67% were worried about the impact of relaxing social distancing rules.

After much deliberation, Cancer Services is transitioning the annual Tribute Dinner to a virtual event for safety reasons. It was a difficult decision. Not only because it has become a beloved tradition, but also because it is an important fundraiser.

Because cancer patients are at a higher risk from COVID-19, Cancer Services needs to be extra vigilant in our response. COVID brought unexpected expenses, such as technology to allow us to continue to safely serve clients, more cleaning supplies costs and personal protective equipment for clients and staff.

The greatest concern is keeping up with the need for financial assistance to help clients with treatment, medication and health insurance costs. Cancer Services estimates financial assistance expenses could be as much as \$100,000 more than what was budgeted for 2020.

Additionally, many groups and organizations that generously hold fundraising events to benefit Cancer Services are unable to hold their activities resulting in about \$88,000 less in donations.
