The best ways to help someone with cancer

Want to help a friend or family member who has cancer? But you're not sure exactly what to do? The experts are here with advice.

Cancer Services of Northeast Indiana's Client Advocates – the experienced professionals who walk side by side with clients and families to ensure they get the help they need – have guidance about ways to support people with cancer (and good advice about well-intentioned efforts that will not help).

"The most important thing is to offer specific help," said Client Advocate Denise Glasser, BS, CSC, "Do not say, 'If you need anything just let me know.' It is not helpful. People with cancer don't always know what help they need and all the decisions they already must make are overwhelming. If you make a concrete offer, it's a lot easier for them to accept your offer of help because they don't have to think about it. Taking that burden off them, that's real help."

Denise, who recently celebrated her 20th Anniversary at Cancer Services, said offers to help with transportation, pickup groceries, do a load of laundry, or mow the yard can be a welcome relief. Just make it clear that the offer of help doesn't come with strings attached. For example, be ready to drop off dinner with the understanding that the family might not be up to having visitors.

Just be sure you find out if there are any foods the patient needs to avoid or has developed an aversion to during cancer treatment.

Denise also is a big proponent of sending cards. The card can be funny or heartfelt, it doesn't matter. People will hold on to the cards they receive for years.

Want to encourage someone to come to Cancer Services for help? Offer to come with them.

Helping a family when a child has cancer takes careful thought too.

"People are chomping at the bit to help," said Sandra Thomas, MSW, the client advocate for children at Cancer Services. "The help these families most need is the ability to spend quality time together as a family."

Offer to run errands, care for pets, or give the child's siblings some needed attention. Consider a donation to Cancer Services in honor of the child. We can put that donation towards one of the therapeutic activities that allows families impacted by cancer to enjoy time together. Because children with cancer are immunocompromised, the family needs to be careful about their child's interactions with people.

Sandra suggests making sure you call the family. "Sometimes people don't call because they don't want to disturb or disrupt the family. You can always leave a simple message letting the family know you are thinking of them. That is always welcome," she said.

Knowing what not to say or do is equally important. Client Advocate Liz Fenimore, MSW, LSW, who provides mental health counseling services said, "If I could put this in neon letters I would. Don't say that it's God's plan, part of a greater plan or that there is any good reason for the cancer. And don't compare it to other people's experience."

So, don't talk about your cancer experience or tell your friend about the co-worker whose chemo treatment was torture or your brother-in-law who had a similar diagnosis and died. It's important to remember that everyone's cancer experience is unique.

Liz said the only time it's ok to compare experiences is if you are specifically asked. Her guidance is to listen carefully to the person you want to help before offering any opinions or advice.

The most important thing is to just be there for the people you care about who have cancer – even if you feel a little uncomfortable. Make sure to show that you still care throughout their cancer journey. Remember, even the smallest gesture can make a huge difference.
